THE SHELTER SERVED 93,822 MEALS AND PROVIDED 40,215 BEDS FOR 1,383 INDIVIDUALS DURING THE YEAR. THE SHELTER'S TRANSITION PROGRAM PROVIDED 2,000 CASE MANAGEMENT CONTACTS AND GRADUATED 37 RESIDENTS. 55 FORMERLY CHRONICALLY HOMELESS INDIVIDUALS RESIDED IN PERMANENT SUPPORTIVE HOUSING THROUGH THE HOUSING FIRST PROGRAM.
